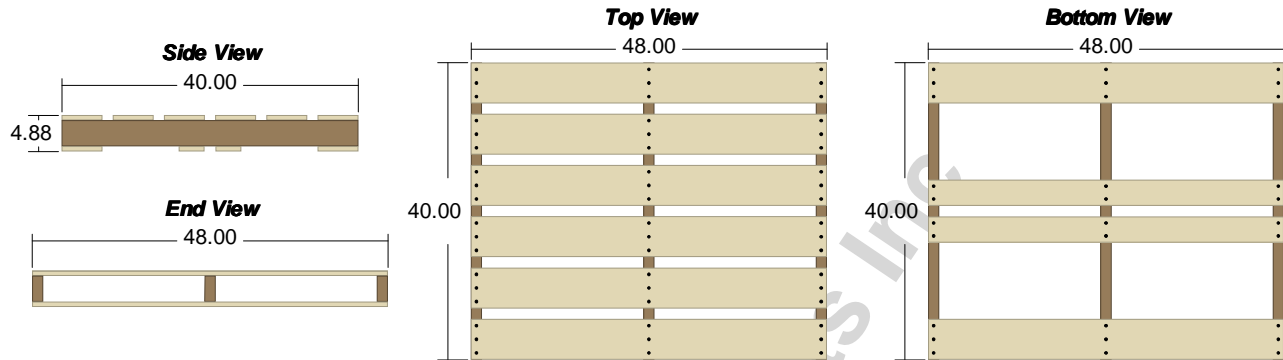

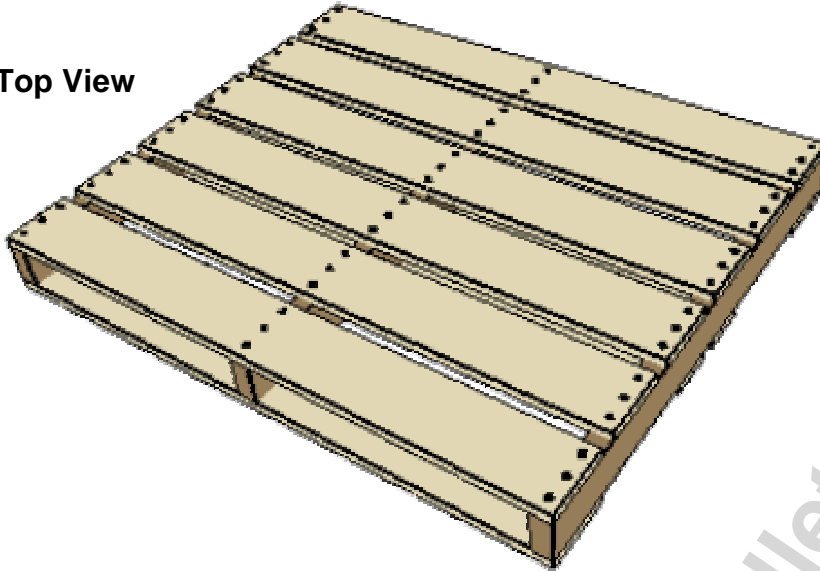

3-D Pallet Drawings

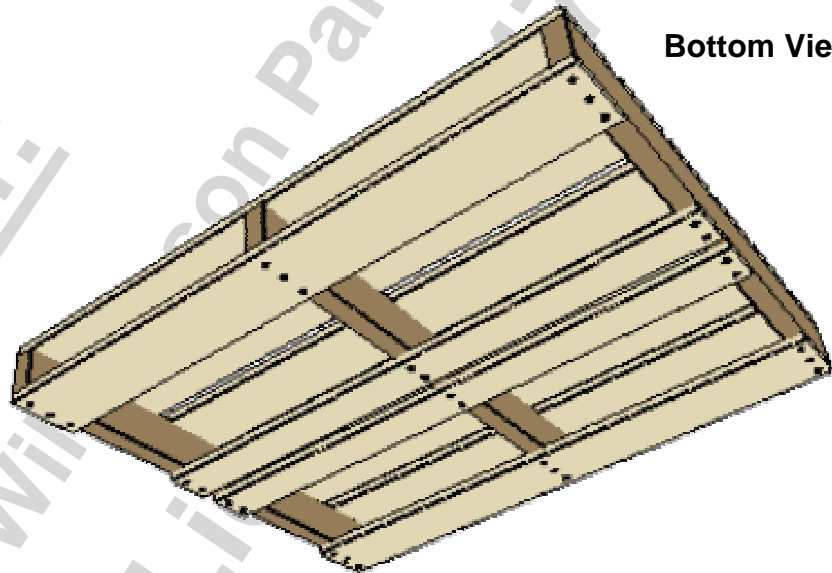
